Tom Haskell updated everyone on the Holiday for Hague which is scheduled for December 5, 2015.

Ginger Kuenzel read a letter from Donna Wotton thanking everyone for their support with the "Made in Hague Store." The store was well attended this year and will be open again next summer. She also thanked Randy Engler for the donation of the building.

Judy Stock asked about the status on the solar proposal. Supervisor Frasier said National Grid had found a problem and they were working on it.

Supervisor Frasier congratulated those who won the election. She noted that 227 out of 600 registered voters came to the polls and most were over 60.

Supervisor Frasier thanked Councilwoman Kuenzel for all of her work with National Grid on the Streetlight District. She found they had been billing the Town for lights we didn't have and will be giving \$7,093 back to the Town. National Grid will also be replacing lights with energy efficient bulbs. Councilman Fitzgerald remarked that according to the GIS system there is some question as to who is in the street light district. He will contact National Grid and compare information.

The Fund for Lake George will provide funds for the tracking system which will record the amount of salt used. The recorders will be placed on the trucks which plow Tongue Mt. and Route 8. Superintendent Smith noted that he has to keep records for the State and will copy any information for Chris Navitsky, Lake George Waterkeeper from The FUND.

- 2. Wages
 - a. Wages and fringe benefits are determined annually during September and October when the Town Budget for the next year is being prepared. Any wage increases therefore would not become effective until the next year's budget becomes effective.
 - a. 1) Special provisions for full-time Highway Department employees who have a Commercial Driver's License (CDL)

Full-time hourly employees in the Highway Department who have a valid CDL receive a 1% wage increase after they achieve a service anniversary that is a multiple of five years of service (i.e. 5, 10, 15, 20, 25, 30, etc.). This wage increase is effective beginning January 1 of the year following the anniversary. It supplements any other increase that the Town Board might approve for that year.

The entry-level salary for the position of full-time hourly employee in the Highway Department with a valid CDL will increase 0.5% annually, effective January 1 of each year.

RESOLUTION TO ENTER INTO AN AGREEMENT WITH WARREN COUNTY FOR SNOW & ICE REMOVAL, SWEEPING & MOWING

WHEREAS, the Town of Hague plows and sands 9.02 mile of County Roads in the Town of Hague for snow & ice control, and

WHEREAS, the County and the Town entered into an agreement dated December 26, 2012 wherein the Town of Hague agreed to remove snow and sand and control ice and snow and to sweep road and sand in the spring for an amount of \$51,411.00 for a term commencing January 1, 2013 and automatically renewing on an annual basis for a period of five years unless there is an increase or decrease in the rates or mileage, and

WHEREAS, Warren County has amended the agreement by increasing the amount paid to the Town for snow & ice control, sweeping and mowing, and

WHEREAS, the County of Warren will pay the Town of Hague \$81,973.92 per the attached rate schedule commencing January 1, 2016, NOW THEREFORE BE IT

RESOLVED, that the Supervisor is hereby authorized to enter into an Amendment Agreement with the County of Warren for Snow & Ice Control on the paved County Roads in the Town of Hague for fiscal year January 1, 2016
