IT IS RESOLVED, that the Warrant amount to be collected for **Sewer District #1** User Fee's for the Town of Hague for fiscal year 1/1/2019–12/31/2019 are as followed:

IT IS RESOLVED, that the Warrant amount to be collected for **Sewer District #2** User Fee's for the Town of Hague for fiscal year 1/1/2019 - 12/31/2019 are as followed:

Capital Cost (minus the 25 property owners who paid full amount in 2010): \$50,000.23
