HAGUE TOWN BOARD MEETING October 8, 2019

<u>A Special Town Board Meeting</u> was held Tuesday, October 8, 2019 regarding Sewer Law Enforcement at the Hague Community Center at 5:00 pm with the following members present:

The Meeting was called to order by Edna Frasier, Supervisor.

A Motion was made by J. Bast and seconded by J. Patchett to open the Meeting at 5:04 pm to audit bills. All voted aye. Motion carried.

The Town Board discussed the statuses of individual properties within the Sewer Districts that have not yet connected. The Board questioned if the appeals received had met the outlined requirements. It was declared that all appeals be treated in a uniform, consistent and fair manner with fact-based determinations.

ZEO Clark discussed considerations for those who were working toward compliance.

Mr. Silvestri pointed out that there is nothing in the Town Law regarding time limitations on the second notices or on establishing financial hardships. He stated that the ZEO has a broad discretion and nothing has been arbitrary about the way the ZEO has been proceeding. He affirmed that there is some confusion on the responsibilities of the ZEO and of the Town Board.

The Board requested that a meeting be set up between Councilman J. Bast, Town Attorney Silvestri, and ZEO Clark to further define the Board's process for enforcement.

A Motion was made by S. Ramant and seconded by M. Fitzgerald, to go into an Executive Session to discuss the employment of an individual at 5:55 pm.

A Motion was made by M. Fitzgerald and seconded by J. Patchett to end the Executive Session, at which no decisions were made.

A Motion was made by M. Fitzgerald and seconded by S. Ramant to resume the Open Meeting at 6:18 pm.

<u>The Regular Town Board Meeting</u> followed in the courtroom, beginning at 6:21 pm with several additional town residents present, including Pamela & Myles Peterson, Matthew Reilly, Judith & Peter Foster, Sheri DeLarm, Barbara Rottier, Joan Clark, Dick Jarvis, Timothy Fiallo- Hwy MEO, Linda Mury- HVFD President, and David Martucci-Sole Assessor.

WELCOME GUESTS/PRIVILEGE OF THE FLOOR:

-Pamela Peterson of 9169 Lakeshore Drive, Tax Map #26.17-2-3, presented her fourth appeal to the Town Board for extreme hardships due to rock ledge. ZEO Clark confirmed that she had received three letters of appeal and that their system was permitted by the Town. Mr. DeFranco discussed the testing of the existing system and declared the system is functioning as it should.

RESOLUTION #105 TAX MAP #26.17-2-3 SEWER COMPLIANCE EXTENSION

On a Motion made by S. Ramant and seconded by J. Patchett,

WHEREAS all requisites for an appeal have been met,

IT IS RESOLVED to grant a five year extension for compliance to 12/31/2024 or until a point of failure of the current septic system, whichever comes first. Any further extension of connection compliance requires further appeal by the owner, the current requirements for such appeal prevailing.

-Matthew Reilly, on behalf of Elizabeth Lee of 9175 Lakeshore Drive, Tax Map #26.17-2-4, property neighbors Peterson's, stated the same conditions apply with rock ledge. ZEO Clark confirmed appeal requirements had been met. Mr. DeFranco tested the system and declared that the system and pumps are properly functioning.

RESOLUTION #106 TAX MAP #26.17-2-4 SEWER COMPLIANCE EXTENSION

On a Motion made by J. Bast and seconded by M. Fitzgerald,

WHEREAS all requisites for an appeal have been met,

IT IS RESOLVED to grant a five year extension for compliance to 12/31/2024 or until a point of failure of the current septic system, whichever comes first. Any further extension of connection compliance requires further appeal by the owner, the current requirements for such appeal prevailing.

Duly adopted by the following roll call vote:

Nays: 0 Carried 5-0 -Peter Foster of 9212 Lakeshore Drive, Tax Map #26.18-1-9, presented his case for an appeal due to financial hardship. ZEO Clark stated that the letter of appeal received was for an extension of time. ZEO Clark also made mention that the current system pre-dates the Town's Sewer Codes. Mr. DeFranco tested the system and declared that although the system is not adequate for the usage, as long as it continues to be pumped regularly it seems to be functioning. The Town Board decided to table the appeal until January when the Board will have further defined its process for enforcement.

-Sheri DeLarm of 8979 Lakeshore Drive, Tax Map #42.12-1-13.2, presented her case requested an extension to allow Mr. DeFranco time to complete an inspection of the current system. ZEO Clark stated that the letter of appeal received was for a financial hardship and rock ledge. The Town Board decided to table the appeal until January or when an engineered inspection of the current system has been completed.

-Barbara Rottier, on behalf of Joan Clark of 37 Lakeshore Mine Road, Tax Map #26.18-1-4, presented the case for her client's financial hardship. It was declared that Ms. Clark has done as much as financially possible to be compliant thus far. Ms. Clark requested an extension of time in order to procure the remaining funding needed to make the connection. ZEO Clark stated that she had done an inspection while in residence and there was no sign of failure, the tank had been recently pumped, and no environmental hazard was found.
