TOWN OF HAGUE ANNUAL FREE CLEANUP - PILOT PROCEDURE SEPTEMBER 19 & 20, 2019

There has been an increasing, overwhelming lack of compliance with and abuse of our Town's Annual Free Cleanup. Therefore, this year (2019) our procedure has been modified to be fair to all residents and to be cost effective for the Town. If this 2019 Pilot Procedure is violated this year, the Town will cease Annual Free Cleanup.

FIVE MAJOR POINTS OF COMPLIANCE:

- (1) Utilization of this service is limited to Town of Hague individual residences only; NO BUSINESSES
- (2) Utilization is controlled by Cleanup Authorization Card issued by the Town, one per residence
- (3) Allowed volume per resident each year is limited to 3 yds³ (one standard size pickup truck load)
- (4) Pickup by the Highway Dept is available only for physically disabled and handicapped residents
- (5) Only "acceptable" items are allowed

PRE-REGISTRATION IS MANDATORY. Advance registration by all residences wishing to participate is mandatory and must be completed by **3:30 pm on Tuesday, Sept 17th, 2019**. Register <u>in person</u> with proper resident identification at The Hague Community Center weekdays between 8:30 AM and 3:30 PM **no later than Sept 17th**. Registrants will be will be issued a **Cleanup Authorization Card**.

TOWN DUMP PROTOCOL. Registered Town residences with a **Cleanup Authorization Card** may bring one standard size pickup truck load, i.e., 3 yds³, **for free** to the <u>TOWN DUMP</u> on THURSDAY, SEPT 19th or on **FRIDAY the 20th from** <u>8:00 AM TO 1:30 PM only</u>. [Note – to the Town Dump, not Town Highway Shed as in past.] No materials will be accepted without presentation of a **Cleanup Authorization Card** which will be collected and logged at the time.

PICKUP PROTOCOL. <u>The Town of Hague Highway Department</u> will do pickups **LIMITED** to pre-registered Hague residents **that are physically disabled/handicapped**.

All items for pickup must be sorted and <u>placed at the roadside</u> prior to 6:00 PM on Wednesday, Sept 18th. Pickup will occur between the hours of 7:00 AM – NOON on Thurs, Sept 19th or on Friday, Sept 20th. One pickup will occur and the **Cleanup Authorization Card** must be presented or materials will not be taken. Items shall not exceed a combined total that will fit into a standard size pick-up truck, i.e., 3 yds³. [See NOTES for additional important pickup accommodations, including <u>for seniors</u>.]

ITEMS ACCEPTABLE AND SORTING. All items, whether at Dump or at curbside, must be sorted.

ACCEPTABLE ITEMS include but are not limited to:

White Goods – stove, washer, dryer, etc.

Furniture - chairs, sofas, rugs, mattresses, etc.

Metal

UNACCEPTABLE ITEMS:

NO Recyclables – NO Garbage – NO Brush/leaves NO C & D (Construction Materials) – NO Tires NO PROPANE TANKS, NO REFRIGERATORS, NO AIR CONDITIONER, NO DEHUMIDFIERS NO TV'S OR ELECTRONICS

PICKUP NOTES.

- The Town has contacted our local companies that do private hauling and these companies will assist senior and physically disabled/handicapped residents in accomplishing the Town's objectives in this year's Event. Seniors and physically disabled/handicapped residents needing help are encouraged to contact these companies directly for this assistance at their residence (see next Note for contact information).
- For all Hague residences, regardless of resident age, if they have ONE (1) LARGE ITEM (e.g., dryer, couch, large table, etc.) for Cleanup Day and can't move it to Dump themselves, these local companies will pick up that one item for NO CHARGE and take it to the Dump:

(Note: North Country Landscape also wanted to participate but has another commitment) At pickup, you must provide the company your **Cleanup Authorization Card** that will be marked for one large item at time of registration.

Any other cleanup items for a residence utilizing this option <u>must be less than 2 yd³and</u> are registrant's responsibility to take to the Dump with their separate **Cleanup Authorization Card**. [Note: If one of the above companies is being used by a residence for ONE LARGE ITEM AT NO-CHARGE, know that there may be a charge for any additional (less than 2 yd³) items if the residence wishes that company to also take those items.]

- Residences are encouraged to contact these companies directly for these services and assistance.

NO DUMPING AFTER DESIGNATED HOURS WILL BE TOLERATED – KNOW THAT THE DUMP IS BEING MONITORED BY SECURITY CAMERAS.

NON COMPLIANCE WITH OR ABUSE OF THESE INSTRUCTIONS MAY RESULT IN DISCONTINUING AN INDIVIDUAL'S PRIVILEGE TO PARTICIPATE IN ANNUAL CLEANUP DAY OR IN THE DISCONTINUATION OF THE ENTIRE TOWN PROGRAM.
