Any decision to reduce your EDU assessment shall apply to future sewer warrants only.

Before filing your appeal, please review Town Board Resolution #78 of 2021 (see page 2 of this form) for information about how EDUs are assessed.

Please note that a bedroom is defined, for purposes of EDU assessments, as any room that is at least 70 square feet in size; has a doorway (even if there is currently no door installed); is not a pass-through to another room.

2	For each additional bedroom in a residence	+ 0.33 EDU / 150 GPD
3	Two or more family residences; apartments (each residence or apartment is treated as single family) * see EDUs on lines 1 and 2	1.00 EDU for each residence or apartment
4	Bunkhouse/Accessory structure w/o kitchen	0.33 EDU per room / 150 GPD

1	Buildings with kitchen and bathroom facilities (church, clubhouse, government building)	2.5 GPD per occupant (use max. occupancy)
2	Buildings with only bathroom facilities (church, clubhouse, government building)	1.5 GPD per occupant (use max. occupancy)
3	Marinas For dump station, add per docking space	10 GPD per docking space 7
4	Office or retail space (incl. Post Office)	0.15 GPD per sq. foot
5	Deli/market (incl. convenience store)	0.25 GPD per sq. foot

7	Rental Accommodations w/o kitchens (hotel, motel, cottages)	150 GPD per sleeping unit / 0.33 EDU
