## **Town of Hague Japanese Knotweed Control Program**

Japanese knotweed is an invasive plant that looks similar in appearance to bamboo. This plant quickly displace native plants. It overtakes and fills in abandoned and disturbed sites rapidly. Japanese knotweed is a problem for property owners because it quickly takes over their property. It also poses environmental problems such as stream bank erosion.

There is a significant Japanese Knotweed population along the Hague Creek corridor. Extending from the lake in the center of town up along W. Hague Rd. and Summit Dr. The Town of Hague has taken the initiative to control this knotweed.

In consideration for allowing control work to be done on your property the Town of Hague is covering the cost.

Japanese knotweed is controlled through application of a glyphosate based herbicide.

The herbicide is applied via stem injection or foliar spray.
