The Special meeting of the Hague town board was held Thursday April 19, 2018 at The Hague community center at 3:30pm with the following members present:

RESOLUTION #70 of 2018- WARRANT FOR COLLECTION OF SEWER DISTRICT #1 & 2 USER FEES, CAPITAL COST & INTEREST FEE'S FOR THE YEAR 2018

Resolution introduced by M. Cherubini and seconded by J. Patchett.

RESOLVED, that the Warrant amount to be collected for **Sewer District #1** User Fee's for the Town of Hague for fiscal year 1/1/2018– 12/31/2018 are as followed:

288.6 EDU's @ \$757.79 AMOUNT TO BE COLLECTED: \$218,698.38

RESOLVED, that the Warrant amount to be collected for **Sewer District #2** User Fee's for the Town of Hague for fiscal year 1/1/2018 – 12/31/2018 are as followed:

158.4 EDU's @ \$671.82 Total: \$106,416.26

Capital Cost (minus the 25 property owners who paid full amount in 2010): \$45,001.04

Interest Payment (minus the 25 property owners who paid full amount in 2010): \$31,520.72.

AMOUNT TO BE COLLECTED: \$182,938.02

TOTAL AMOUNT TO BE COLLECTED: \$401,636.40

AND BE IT FURTHER RESOLVED that the Sewer Collector is hereby ordered to receive and collect the above amounts from May 1, 2018 to July 31, 2018.

Ten percent (10%) penalty will be added to Sewer District 1 & 2 bills for payments received **after** June 30, 2018. The last day of payment is July 31, 2018, thereafter **all unpaid** Sewer

District #1 & 2 bills will be sent to Warren County Treasurer to be relieved on the Town & County tax bill.
