The applicants would like to extend an existing 8' wide deck another 3'6" and install an attached pitched roof over existing docks. All of the proposed activities are over the waters of Lake George, but are attached to a legal nonconforming structure which is partially over land.

Zoning issue: 160-50 B

Robert Goetsch asked why they wanted to do this. Jim Beaty replied that the deck was currently too narrow for a person to walk around a table with chairs. In addition, since it needed to be removed to complete other, already approved construction it is the perfect time for this request. ZEO Clark stated that the LGPC will also have to approve this project if the Variance is granted. The APA has given authority to the LGPC for boathouses and sundecks on Lake George. The house is less than one third over land. Chris Navitsky stated that this would be an increase of non-conformity. Issue is that the deck is connected to the house although the deck is completely over the water. Chris would like to see a hardship documented.

The free standing garage will be removed. A new garage will be attached to the house. Chris Navitsky said that the area stated is not correct looking at the floor plans. The basement is not included unless it is finished. The new house will be built over part of the existing driveway.

The board agreed that the overhang is to be with the sideline setback.
