RESOLUTION # 59 OF 2018

LOCAL ORDINANCE 1 OF 2018 EXTENDING THE MORATORIUM FOR SIX MONTHS ON THE SOLAR PANELS IN THE TOWN OF HAGUE.

RESOLUTION introduced by M. Cherubini and seconded J. Patchett.

NOW, THEREFORE, BE IT ENACTED BY THE HAGUE TOWN BOARD AS FOLLOWS:

1. Title and Authority – This Local Ordinance shall be known as the Town of Hague Solar Panels Moratorium Ordinance. It is adopted pursuant to Municipal Home Rule Law §10.

2. Purpose – The Town Board recognizes that solar energy may offer benefits for energy conservation and reduction of reliance on fossil fuels. However, the installation of solar panels may have impacts on neighboring properties including visual impacts and clearing of trees. The Town Board believes that this moratorium is necessary in order to allow the Code Committee and Planning Board time to investigate the relevant issues and adopt a Local Ordinance regulating solar panels consistent with the development objectives of the Town. It is the intent of the Town Board to adopt a Local Law to address the installation of solar panels in general.

3. Definitions – "Solar Panel" means a device that produces electricity from sunlight using photovoltaic cells or other technology and any related equipment and accessories for use in an associated building or buildings or for offsite sale and/or consumption.

4. Moratorium – The Town of Hague hereby imposes a moratorium on the construction, installation, review or approval of any solar panels or applications for solar panels commencing ten days after the publication of the new ordinance in the town's official newspaper and terminated six months after that date. The provisions of this Local Ordinance shall be applicable to any construction, installation, review or approval of any solar panels or applications for solar panels, including any applications which are currently pending, unless all necessary approvals have been obtained and actual physical construction or installation has been substantially commenced as of August 8, 2017. For the purpose of this Local Ordinance, construction, installation, review or approval shall include undertaking of any new or expanded solar panels, issuance of a building permit, application of review standards, conducting a Public Hearing or rendering a final decision or any approval which would in any way authorize the construction, installation or use of solar panels.

5. Extensions – This moratorium may be extended for such additional periods as the Town Board may determine to be necessary to protect the public health, safety and welfare of the citizens of the Town of Hague.

6. Variance Procedure – The Town Board shall have the power, after a Public Hearing, to vary or modify the application of any provision of this Local Ordinance upon its determination that strict application of this Local Ordinance would impose extraordinary hardship upon an applicant and that the variance granted would not adversely affect the health, safety or welfare of

the citizens of the Town. Any request for a variance shall be filed with the Town Clerk. If the Town Board, in its sole discretion, determines to consider the variance application, the Town Board shall conduct a Public Hearing on at least five (5) days' public notice and make its decision within thirty (30) days after the close of the Public Hearing.

7. Termination – This moratorium shall be terminated upon adoption of a Local Law or Ordinance governing the siting, installation, construction and/or use of solar panels in the Town of Hague.

8. Severability – The invalidity of any clause, sentence, paragraph or provision of this Local Law shall not invalidate any other clause, sentence, paragraph or part thereof.

9. Effective Date – This Local ordinance shall take effect after adoption by the Town Board and ten days after the publication of the new ordinance in the town's official newspaper.

RESOLVED, that if adopted, the revised Plan will be sent to Regional Planning Department.

NOW, THEREFORE, BE IT RESOLVED, by the town Board of the Town of Hague that the assessments of Taxable State owned land should remain under the control of the local municipality where such property is located and is hereby opposed to the New York State converting the assessment of the Taxable State owned land into a Payment in Lieu of Taxes, and
