- <u>Applications in front of the Board</u>:
 1. SISCA (76.20-1-3.1) 8 Silver Bay Road (TRIR) VAR 05-17 for a fence within 50' of the MHW of the lake. Approved with the condition that it is to be a split rail fence.
- <u>Violations:</u> There are currently 8 active violations with two violations satisfied this month.

The installation of fences and shed without a permit seem to be the biggest problem.

All Structures require a Land Use & development permit and need to meet the setback for the Zoned area. Failure to obtain a permit prior to the installation of said structure is a violation of the Codes of the Town of Hague.

§ 160-10 The definitions:

STRUCTURE- Any object constructed, installed or placed on land to facilitate land use and development or subdivision of land, such as but not limited to buildings, sheds, single-family dwellings, mobile homes, fences, signs, tanks, poles and any fixtures, additions and alterations thereto.

<u>§ 160-83 Land use and development permits; issuance; expiration.</u>

A. No person shall undertake any new land use or development unless and until the Zoning Administrator has issued a land use and development permit therefore, except that no permit by the Zoning Administrator shall be required under this article for a

new land use and development which is a Class A regional project subject to Adirondack Park Agency project permit jurisdiction.

[Amended 11-10-1998]

B. Issuance of land use and development permits. The Zoning Administrator shall not issue a land use and development permit unless the Zoning Administrator determines:

[Amended 11-10-1998]

(1) The new land use or development complies with any applicable sanitary codes;

(2) The new land use and development meets the area, setback, bulk and height controls and the special shoreline restrictions of this chapter, unless an area variance has been granted pursuant to Article XII hereof;

(3) It is an accessory use or a use permitted by right or the new land use or development has received site plan approval, if applicable, and, if such approval is subject to conditions to be met prior to the granting of a permit, that all such conditions have been met;

(4) It is a nonpermissible use for which a use variance has been granted pursuant to the terms of Article \underline{XII} hereof and, if such grant was subject to conditions to be met prior to the granting of a permit, that all such conditions have been met; and

(5) It is a sign, and such sign complies with the provisions of this chapter.

C. Expiration of land use and development permits. If a project for which a land use and development permit has been issued is not in existence within two years after the issuance of such permit, said permit shall expire, and the project may not thereafter be undertaken or continued unless a new permit has been applied for and issued in the same manner and subject to all provisions governing the initial application for and issuance of a permit, unless the terms of the initial land use and development permit for the project provide for a longer period of time, in which case the permit shall expire at the end of that longer period.

Cathy mentioned that there have been 19 violations this year. Any work being done should go through the zoning office. Right now only the homeowner is fined, even if the contractor should know better. Lake George fines both the homeowner and the contractor and the fines are much higher.
