This letter provides information regarding the Short-Term Rental Local Law #1 of 2024 regulating short-term rentals in the Town of Hague. Detailed information about this law can be found at the website: TownofHague.org or at the Town Clerk's office at the Community Center at the address above.

Attached you will find the following forms and documents:

- 1. Short-Term Rental Application (STR-1). This is the first step in the short-term rental application process. Please fill out this form completely. Upon approval, this form will serve as your rental permit.
- 2. Template of Rules and Regulations (STR-2). This template provides a summary of minimum requirements for all short-term rental guests. Additional rules may be added by the property owner, as desired. Owners may use this template or revise it. However, the rules within the template must be maintained at a minimum. A copy of the rules shall be provided to the Town of Hague along with the permit application.
- **3. Sample Site Plan and Blank Site Plan Sheet (STR-3).** These pages are provided to assist you in providing a sketch of your property. The sample site plan illustrates how you should prepare a site plan of your property using the blank site plan sheet.

Additionally, you must provide the following as part of your application:

- A nonrefundable application fee of \$300.
- A copy of the deed or other instrument that demonstrates ownership of the property as recorded by the Warren County Clerk's Office.
- A valid certificate of Authority issued by Warren County Treasurer's Office authorizing the
 collection of Warren County Occupancy Tax from short-term renters. The occupancy bed tax is
 to be collected by rental owners on behalf of Warren County. Address any questions on this
 responsibility to the Warren County Treasurer's Office. Occupancy tax forms are available from
 the Warren County website: https://warrencountyny.gov/treasurer/bedtax
- A copy of Warren County Fire Safety Inspector report. This will establish the number of eligible bedrooms and max occupancy limit. <u>Warren County: 518-761-6542</u>
- A current Certificate of Compliance issued by the Town of Hague Zoning Officer stating that the short-term rental property conforms to all requirements of the Town of Hague Building Code and that there are no open or pending zoning violations or enforcement proceedings.
