NEW BUSINESS:

1. RACANELLI (60.9-1-49) 10 Bobkat Ln (TR1) VAR 01-16

The owner would like to replace and reconfigure existing shoreline patios, walkway and steps. They also would like to replace existing wood retaining walls with new wood retaining walls. According to their engineer the existing impervious area is 438.5 sq. ft., the proposed area will be 531.5 sq. ft., if approved. Three white pines trees are planned to be removed and will be replaced with extensive vegetative planting.

Zoning issue: 160-50 Shoreline

Racanelli continues:

ZEO Clark stated that the trees being removed are allowed. She also provided information from letters. The planning board made a positive recommendation. Warren County determined "no County impact." The Arcady Bay Association approved his application.

Discussion: Chris Navitsky asked about trees and bushes being planted. Tony DeFranco stated that between two and three hundred trees and planted would be planted.

Jon Hanna made a motion to approve this application.

- f. Is the alleged difficulty self created?Just by the fact the area has deteriorated over time.
